



Für die SINCONA Auktion 49 gelten folgende Versteigerungsbedingungen, welche durch die Abgabe eines schriftlichen, elektronischen, mündlichen oder telefonischen Gebotes vollumfänglich anerkannt werden:

- Die Versteigerung erfolgt freiwillig und öffentlich im Namen der SINCONA Swiss International Coin Auction AG für Rechnung des ungenannt bleibenden Einlieferers und unter Beachtung der Regeln der International Association of Professional Numismatists (IAPN, www.iapn-coins.org).
- Der SINCONA Swiss International Coin Auction AG (im Folgenden "Versteigerer" oder "SINCONA AG" genannt) unbekannte Bieter sind gebeten, sich vor der Auktion zu legitimieren. Ferner behält sich der Versteigerer vor, nach freiem Ermessen und ohne Angabe von Gründen Personen den Zutritt zu den Auktionsräumlichkeiten zu untersagen.
 - Der Versteigerer ist mit Zustimmung der Auktionsaufsicht berechtigt, von der im Katalog vorgesehenen Reihenfolge abzuweichen und Nummern zu vereinigen. Lose werden nicht aufgeteilt. Bei Meinungsverschiedenheiten kann ein Los vom Versteigerer erneut ausgerufen werden. Die Auktion wird in deutscher und teilweise in englischer Sprache durchgeführt.

- 13. Die Echtheit der Auktionsgüter wird gewährleistet. Der Gewährleistungsanspruch wird ausschliesslich dem Käufer eingeräumt und darf nicht an Dritte abgetreten werden. Die Geltendmachung des Gewährleistungsanspruchs setzt voraus, dass der Käufer gegenüber der SINCONA AG sofort nach Entdeckung des Mangels mit eingeschriebenem Brief Mängelrüge erhebt und der SINCONA AG das gefälschte Auktionsgut im gleichen Zustand, wie es ihm übergeben wurde, und unbelastet von Ansprüchen Dritter zurückgibt. Der Käufer hat dabei auf eigene Kosten den Nachweis zu erbringen, dass es sich beim Auktionsgut um eine Fälschung handelt. Die SINCONA AG kann vom Käufer verlangen, dass dieser auf eigene Kosten Gutachten von zwei unabhängigen und in dem Bereich anerkannten Experten einholt, ist aber nicht an solche Gutachten gebunden und behält sich das Recht vor, zusätzlichen Expertenrat auf eigene Kosten einzuholen.
- 14. Conditions of Auction

The following conditions of auction, which are deemed to be accepted in full upon submission of a written, electronic, verbal or telephone bid, apply to SINCONA auction 49:

- The auction is carried out voluntarily and publicly in the name of SINCONA Swiss International Coin Auction AG for the account of the consignor, who remains anonymous. The auction is conducted according to the rules of the International Association of Professional Numismatists (IAPN, www.iapn-coins.org).
- Bidders who are unknown to SINCONA Swiss International Coin Auction AG (hereinafter referred to as "Auctioneer" or "SINCONA AG") are asked to prove their identity prior to the auction. In addition, the Auctioneer reserves the right to deny individuals access to the auction premises, at its own discretion and without stating a reason.
 - The Auctioneer is entitled, with the approval of the auction monitor, to deviate from the designated order in the catalog and to combine lot numbers. Lots may not be divided up. In case of disagreement, the Auctioneer may re-offer a lot. The auction is conducted in German and partly in English.
- 3. The Auctioneer executes written orders and telephone orders diligently and in the interests of the consignor, however without liability. Written bids (and bids submitted electronically) can only be considered if they are received no later than 24 hours prior to the auction (or 12 hours for bids submitted via an Internet platform). In principle, telephone bidding is possible and bids must be placed at least 48 hours before the auction begins. A successful telephone line can not be guaranteed.
 - SINCONA AG and the operator of the "live bidding" platforms provided shall endeavour to guarantee the availability and fault-free operation of these platforms. It shall be for the bidder to obtain information promptly concerning the technical prerequisites and requirements of these platforms and to implement any installations and adjustments that may be necessary. SINCONA AG refuses any liability for losses or other claims resulting from interruptions or delays resulting from technical faults or defects. Bidders shall have the possibility to submit so-called "proxy" bids prior to the action on the "live bidding" platforms provided, i.e. to inform the operators of the platform of their personal maximum bid limits, which shall be taken into account by the operators present on the relevant platform in the hall in the event of the failure of the internet connection or the platform.
- 4. Only the descriptions of each respective lot number in the printed catalogue, and not the illustrations, are binding for the auction. The auction catalogue published on the internet is for information purposes only.
- 5. The prices in the catalogue are starting prices in Swiss Francs (CHF) and represent the minimum knock-down price. Bids that are lower than the starting price can not be taken into account. The award takes place following a call for the highest bid, which

- commits the highest bidder to purchase the lot. If equally high written bids are received, the first received bid has priority. "Either / or" orders and order limits can only be executed or considered conditionally. The Auctioneer may reject a bid, without stating a reason and without liability. The risk passes to the buyer with the fall of the hammer. Each successful bidder is personally liable for his purchases and can not claim to have bought for the account of third parties.
- 6. A premium of 20% is payable on the hammer price. For winning bids submitted using a live bidding system the premium is also 20%. After the knockdown has taken place, the auction invoice is due for immediate payment in the Swiss currency.
- There will no statutory value added tax be charged on the total of the auction invoice (i.e. hammer price plus buyer's premium and any shipping costs and insurance premiums).
- 8. The auction invoice is due for payment immediately upon receipt, however by no later than 10 days after the end of the auction. After expiry of the payment period, the buyer automatically falls into arrears and the Auctioneer is entitled to demand interest at the rate of 10% p.a. If the buyer is in default of payment or refuses to accept the auctioned lot, the Auctioneer reserves the right to sue the buyer for either fulfilment of the contract or for compensation for losses resulting from nonfulfilment, or to withdraw from the contract.
- 9. In principle, the auction lot is only handed over or shipped after full payment of the auction invoice. It is at the sole discretion of the Auctioneer to hand over the lot on account. Costs incurred abroad, such as customs duties and taxes, as well as the associated shipping costs and insurance charges, are borne solely by the buyer.
- 10. The auction item remains the property of the consignor until the auction invoice has been paid in full.
- 11. Compliance with foreign customs and exchange regulations etc. is the responsibility of the buyer. The Auctioneer expressly disclaims responsibility for any consequences that may arise from contravention of such regulations.
- 12. The lot to be auctioned is described to the best of our knowledge and belief and with great care. Bidders have the opportunity to inform themselves about the condition of the lot, in person or through a representative, during the viewing days listed in the catalog.
 - Justified complaints regarding the condition of the auctioned item must be received by SINCONA AG by registered letter. Claims due to disagreement about the level of conservation of a lot are not accepted.
 - SINCONA AG does not warrant that the state of preservation presented in the catalogue will be accepted after the sale by a



grading institute (such as PCGS or NGC) should the lot be certified by them.

- 13. The authenticity of the auction items is guaranteed. The right to claim warranty is granted to the buyer only and can not be assigned to third parties. The assertion of the warranty claim requires the buyer to give notice of defect to SINCONA AG by registered letter immediately after discovery of the defect and the forged auction item must be returned to SINCONA AG in the same condition as it was handed over to the buyer, unencumbered by third party claims. The buyer must, at his own expense, provide proof that the auction item is a forgery. SINCONA AG may require the buyer to seek the opinion of two independent experts recognized in the field, at the buyer's own expense; however, SINCONA AG is not bound by such opinion and reserves the right to seek additional expert advice at its own expense.
- 14. Justified claims of the buyer against SINCONA AG concerning the condition or falsity of the auction item are limited to the refund of the purchase price and the premium paid by the buyer (including any VAT). Further or other claims of the buyer against SINCONA AG or its employees are excluded under any legal title whatsoever.
- 15. The names of the consignor and the buyer are not normally disclosed. The Auctioneer is entitled to exercise all rights of the consignor against the buyer arising from the contractual relationship in its own name.
- 16. The place of fulfillment and the exclusive place of jurisdiction is Zurich 8001, Switzerland. In addition, Swiss cantonal and federal laws apply. The auction and all related legal transactions are subject exclusively to Swiss law.
- 17. The original German text is authoritative for the interpretation of the present conditions of auction in the English language.

PREFACE

The formation of the Kian Collection began in the late 1970's with the aim of creating the finest collection of the modern machine-struck coinage of the Qajar and Pahlavi Dynasties. In pursuit of this, many of the finest coins and medals were acquired from some of the most distinguished collections of the twentieth century, notably King Farouk of Egypt, Mortimer Hammel, J. W. Garrett (the John Hopkins University Collection, Baltimore), Abe Kossoff, Turath, J. Schulman and Dr. M. Abgarians. Provenance is an important factor in today's market, and the majority of the major pieces here are recorded with the name of the original vendor and the date acquired.

From the outset emphasis was placed on rarity and quality, while at the same time working towards making the collection as comprehensive as possible. In pursuit of perfection, many coins have been upgraded several times in order to obtain the finest known examples to exist. In terms of rarity the phrase "only known specimen" appears throughout the catalogue.

To note a few – the gold Pattern or Kran by W. Bain of Fath-Ali Shah (Lot 1); the two spectacular 25 Toman coins of Naser al-Din Shah dated 1307 and 1313 AH (Lot 349 & 350); the brilliant 10 Toman of Mozaffar al-Din Shah of 1318 AH (Lot 140); Gold Medallic 5 Toman of Mohammad Ali Shah dated 1326 AH (Lot 187); the unpublished 5000 Dinar Lion & Sun type dated 1326 AH from Mohammad Ali Shah (Lot 196); the 2000 Dinar, Coronation type of Ahmad Shah struck in gold (Lot 243).

The Kian Collection, as evidenced by this catalogue, has achieved the original aim to create the definitive collection for this series. It is no exaggeration that it is the finest offering of the Qajar and Pahlavi machine-struck coinage to be placed at auction. Being offered as a single Lot this is a unique opportunity to acquire a truly irreplaceable numismatic piece of history.

MONETARY STANDARDS

The milled coinage of Persia started in 1293 A.H. (1876), which coincides with Nasser al-Din's 30th Year of Reign. Before this date there were a small number of medals struck in Great Britain and Russia to commemorate some important events. In 1281 A.H. a few Patterns in gold, silver and bronze were also struck, which in most cases served as models for the future regular issues. The examples from the first two years (1293-1295 A.H.) are generally very rare, and it was only in 1296 A.H. that a greater number of coins and medals started to circulate.

Prior to 1293 AH, a Toman was the gold currency unit with the weight of 50 grains (3.24 grams), and a Kran was the silver unit weighing 78 grains (5.05 grams). The weight of some early milled issues (1293-1295 AH) are based on the old standards of the hammered coins. The standard units of the machine struck coinage of Persia from 1876 to 1941 are as follows:-

1 1293-1344 AH (1876-1925)

- gold Toman of 44 grains (2.85grams).
- silver Dinar of 0.072 grains (1000 Dinars = 4.67 grams).
- bronze & copper alloy Shahi of varying weights but equal to 50 Dinars in value.
- copper & copper alloy Dinar of varying weights but equal to 1/50 of Shahi in value

2 1304-1310 SH (1925-1931)

- gold Pahlavi of 30 grains (1.95 grams)
- silver Dinar unchanged
- bronze & copper alloy Shahi unchanged
- copper & copper alloy Dinar unchanged

3 1310-1320 SH (1931-1941)

- gold Pahlavi of 125 grains (8.10 grams)
- silver Riyal of 78 grains (5.05 grams)
- bronze & copper alloy Shahi of varying weights but equal to 5 Dinars in value
- copper & copper alloy Dinar of varying weights but equal to ½ Shahi in value.

QAJAR

Fath-Ali Shah 1212-1250 AH (1797-1834 AD)





Fath-Ali Shah was the second King of the Qajar Dynasty who reigned from June 17, 1797 to October 23, 1834. He was born in Damghan on September 25, 1772 and died in Esfahan on October 23, 1834. He was son of Hossein-Gholi Khan, brother of Agha-Mohamad Khan, the first King of the Qajars.

After his coronation in 1797, he changed his name from Baba Khan to Fath-Ali, the name that his great-grandfather bore. There are some rare hammered coins struck in Tehran and Esfahan with his initial name of Baba Khan.

The reign of Fath-Ali Shah is marked by the ceding of Persia's North-Western territories in the Caucasus to Russia, including Georgia, Daghestan, Azarbaijan and Armenia, which was later confirmed by conclusion of the Golestan and Turkamanchai treaties in 1814 and 1828.

During his reign there was a resurgence of Persian art and painting. The portraiture and large- scale oil paintings reached a height previously unknown under any other Persian dynasty. The Kiani crown (Royal Crown), created by his uncle, Agha -Mohammad Khan was modified and large numbers of pearls and gems were added.

After the death of his son, Crown Prince Abbas Mirza on October 25, 1833, Fath-Ali Shah named his grandson Mohammad Mirza as his successor. Fath-Ali Shah died a year later in 1834 and was buried in the Shrine of Fatemeh Maasumeh in Oom.

In 1808 the British envoy Sir Harford Jones was given a mission by King George III to negotiate a treaty of alliance between Persia and Great Britain. A preliminary agreement was concluded in March 1809 and the definitive treaty was eventually signed on 25 November, 1814. By the terms of this important document, which was specially declared to be defensive, all alliances between Persia and European nations hostile to Great Britain were made null and void, and all European armies were to be prevented from entering Persia, if hostile to Great Britain. In 1828 the British Minister, Sir John Macdonald renegotiated and modified some terms of this treaty, and it is reported that on this occasion these medals in gold and silver were offered to the dignitaries of the court.

Naser al-Din Shah 1264-1313 AH (1848-1896 AD)





Naser al-Din Shah, son of Mohammad Shah, was King of Persia from September 5, 1848 to May 1, 1896 when he was assassinated. His reign is the third longest in Persian history after Shahpour II of the Sasanian Dynasty and Tahmasb I of the Safavids.

He was born in Tabriz on July 16, 1831. Naser al-Din Shah was in Tabriz when he heard of his father's death in 1848 and ascended to power with the help of Amir Kabir who later became his Prime Minister.

Naser al-Din Shah was the first modern Persian monarch to visit Europe, to which he travelled on three occasions. The first visit took place in 1873, the second in 1878 and the final journey was in 1889. During his first visit to Great Britain in 1873, Queen Victoria appointed him a Knight of the Order of the Garter, the highest English order of chivalry.

His reforms included the introduction of a new tax system, building of some military factories, the creation of the Cossack Brigade and the opening of Dar al-Fonoun, an important school of higher education. He also established the Imperial Bank of Persia in 1889 and made improvements to the postal service. Naser al-Din Shah was interested in painting and photography as well as history and geography and had many books on these topics in his library.

Whilst visiting and praying at the Shrine of Abdol-Azim, he was assassinated by Mirza Reza Kermani, a follower of Jamal al-Din Afghani. The assassination happened just before the planned festivities for the 50th Year of Reign. He was later buried in the same shrine situated in Ray near Tehran.



Mozaffar al-Din Shah 1314-1324 AH (1896-1907 AH)





Muzaffar al-Din Shah was born in Tehran on March 23, 1853 and spent 35 years as the Crown Prince and governor of the Province of Azarbaijan before his accession to power on May 1, 1896 after the assassination of his father Naser al-Din Shah. At the beginning of his reign, Persia faced a financial crisis, with annual government spending far in excess of revenues, due to the policies of his father.

He created the Majles (National Consultative Assembly) in October 1906, by which the monarch's power was curtailed, but the actual Constitutional Revolution took place after his death during the reign of his successor, Mohammad-Ali Shah. Other reforms during his reign included the improvement of the Central Treasury and better management of government expenditures.

Like his father, he visited Europe three times with journeys to England, France, Belgium, Italy and Russia. On the occasion of his first visit in 1900, the English court was in mourning, and consequently the Shah was not invited. He visited England two years later during his second tour to Europe in 1902.

Forty days after the signing of the Constitution in the Assembly, Muzaffar al-Din Shah died on January 3, 1907 and was buried in the Shrine of Fatemeh Maasumeh in Qom.



Mohammad-Ali Shah 1324-1327 AH (1907-1909 AD)





Mohammad-Ali Shah was born in Amol on June 21, 1872 and reigned from January 3, 1907 to July 16, 1909.

He was opposed to the Constitution which was ratified during the reign of his father Mozaffar al-Din Shah in late 1906. Mohammad-Ali Shah dissolved the Assembly in 1907 and declared that the Constitution was contrary to the Islamic tradition. He ordered the bombardment of the Parliament building, which was carried out by the Cossack Brigade, shortly after the dissolution of the Assembly.

In July 1909 the pro-constitution forces from all provinces marched to Tehran and deposed the King and re-established the Constitution. On July 16, 1909 the Assembly voted to enthrone Mohammad-Ali's son, Ahmad Shah. Mohammad-Ali Shah abdicated following the Constitutional Revolution and fled to Odessa with the help of some Russian diplomats stationed in Tehran. He attempted to regain power in 1911 and landed in Astarabad in the North-Eastern province of Golestan, but his forces were defeated, and he went back to Russia for a few months before moving to Constantinople in Turkey. He finally settled in San Remo, Italy where he died on April 5, 1925 and was buried in the Shrine of Iman Hossein, in Karbala, Iraq.



Ahmad Shah 1327-1344 AH (1909-1925 AD)





Ahmad Shah was born in Tabriz on January 21, 1898 and ascended to the throne after the removal of his father Mohammad-Ali Shah by the Parliament on July 16, 1909. Due to his young age, his uncle, Ali-Reza Khan, took charge of his affairs as Regent. Upon reaching his majority Ahmad Shah was formally crowned on July 21, 1914.

In 1917 Great Britain used Persian territory to launch an attack into Russia in an unsuccessful attempt to reverse the Russian Revolution. Russia responded by annexing portions of Azarbaijan, much like its Tsarist predecessor. The inaction of the government against such aggression by a foreign power sparked anger among many traditional Persians who felt that Persia's sovereignty had been infringed.

On February 21, 1921 after a turbulent reign filled with internal unrest and foreign intrusions, he was pushed aside in a military coup by his Minister of War and Commander of the Cossack Brigade, Colonel Reza Khan. Ahmad Shah went into exile in 1923 and was officially deposed on October 31, 1925.

When Reza Shah was proclaimed King by the Assembly taking the title of Reza Shah Pahlavi, the Qajar dynasty was effectively terminated. Ahmad Shah died in Neuilly-sur-Seine near Paris on February 21, 1930 after a long illness and was buried in the family mausoleum in Karbala, Iraq.



PAHLAVI

Reza Shah 1304-1320 SH (1925-1941 AD)





Reza Shah, son of Abbas-Ali Khan, the founder of the Pahlavi Dynasty was born in Alasht, Mazandaran on March 15, 1878. He reigned from December 15, 1925 to September 16, 1941.

At the age of 16 he joined the Cossack Brigade, and also served in the army. In 1911 he was promoted to First Lieutenant, by 1912 he was elevated to the rank of Captain and by 1915 he became a Colonel. In February 1921, as leader of the entire Cossack Brigade based in Qazvin he marched towards Tehran and seized the capital. He forced the dissolution of the government and installed Zia al-Din Tabatabaie as the new Prime Minister. Reza Khan's first role in the new government was Commander-in-Chief of the Army and the Minister of War. After the deposition of Ahmad Shah by the Parliament on October 31, 1925, Reza Khan was declared the new King of Persia by the Assembly and was given the title of Reza Shah Pahlavi.

During Reza Shah's 16 years reign, many major projects, developments and important reforms took place. His most notable achievements were the Trans-Persian Railways, the University of Tehran, the National Bank of Iran, along with the building of numerous highways, bridges and dams. He achieved the liberalisation of women's rights and the representation of all religious minorities in the Parliament. He also initiated some changes in foreign affairs, annulling the 19th Century capitulations to Europeans in 1928 and in 1932 unilaterally cancelled the oil concession awarded to William D'Arcy.

On August 1, 1941, the Allied forces invaded and occupied Persia by a massive air, land and naval assault. The Shah ordered the Persian military to end resistance and a ceasefire was declared.

In a hand-written letter by his Prime Minister, Mohammad-Ali Foroughi, Reza Shah announced his abdication in favour of his son, Mohammad-Reza, on September 16, 1941. After three years in exile, Reza Shah died on July 26, 1944. After his death, his body was carried to the Royal al- Rifa'i Mosque in Cairo, and in May 1950 his remains were flown back to Persia and buried in Ray, near Tehran.





Mohammad Reza Shah 1320-1358 SH (1941-1979 AD)





Mohammad Reza Shah was the eldest son of Reza Shah and his second wife, Tadj ol-Molouk. He was born in Tehran October 26, 1919 and was proclaimed Crown Prince on the occasion of his father's coronation on 24 April 1926. Mohammad Reza Shah was the first Iranian Prince to be educated abroad, studying at Institut Le Rosey in Switzerland, which left him with a life-long admiration for all things French. He later attended military school in Tehran and after graduating, he quickly rose to the rank of Captain.

He succeeded his father, Reza Shah after his abdication on September 16, 1941. On 26 October 1967, twenty-six years into his reign as Shah, he took the ancient title Shāhanshāh in a lavish coronation ceremony. Beside him was his third wife, Farah Diba, who he married in 1959 and with whom he had four children. Mohammad Reza made major changes to modernise Iran and during his reign, the national Iranian income showed an unprecedented rise for an extended period.

He was diagnosed with cancer in 1974 (unknown to the public) and he died in exile in on 27 July 1980. He was given a state funeral in Egypt and is buried in the al-Rifa'i Mosque in Cairo.

After the conclusion of a peace treaty between Persia and Russia in 1828, a Russian mission under M. Grebaiodov was sent to Tehran by Tsar Nicholas I. The mission was received with honour, but the envoy's claim for the surrender of two Armenian women by a high-ranking court official created a riot and a mob stormed the Russian Embassy, murdering the envoy and his staff. In dismay the Shah dispatched his grandson, Khosrow Mirza to offer the apologies of the Persian Government, which were eventually accepted. In the following year Khosrow Mirza officially visited Russia again and this extremely rare medal commemorates his visit in 1829.

Ever since his accession to power, Mohammad-Ali Shah had strong opposition from the more liberal members of the Assembly. After the failure of the first attempt to destroy the Constitution in 1907, efforts were made to bring about better relations between the Shah and his subjects, and a Conciliation Committee was formed, but the gulf between absolutism and democracy was too wide to be bridged. On June 23, 1908 by the order of the Shah, the troops surrounded the parliament and artillery fire was opened, destroying a large part of the Assembly House.


